Priority 1	Develop an individualised profile for disadvantaged children by working closely with all stakeholders to establish the root cause of low attainment, specific to each child; create a personalised approach to raising outcomes by addressing each individual pupil's needs.
Priority 2	Work to improve the attendance and punctuality of disadvantaged pupils, so that attendance meets or exceeds national non disadvantaged percentages.
Barriers to learning these priorities address	Thorough understanding of individual circumstances.  Opportunities to engage in detailed analysis and discussion, surrounding each individual child's specific circumstances, barriers and needs.  Overcoming social, emotional, physical and mental health issues by developing children's toolkit of self-regulation strategies.

Priority 2	Establish small group maths interventions for disadvantaged pupils falling behind age-related expectations
Barriers to learning these priorities address	CPD programmes, strategies and interventions given deeper consideration and checked against the evidence base before implementation.  Children have missed several months of teaching and learning due to the national lockdowns; engagement with home learning was limited in some disadvantaged families, resulting in gaps in knowledge.  Current inconsistencies in pedagogy and practice in some year groups.

Priority 1	Increasing the number of pupils attending Breakfast Club. Improving the provision available at Breakfast Club.
Priority 2	Improving protocols for attendance to support families with the most need.
Priority 3	Financial support to increase access to extracurricular provision.
Barriers to learning these priorities address	Attendance, punctuality and readiness to learn for the most disadvantaged children. Financial burden preventing pupils from enjoying clubs, trips and residentials.

Area	Challenge	Mitigating action
Teaching	Prioritising evidence based CPD that matches pupils' needs.	Use of training days prioritised and mapped more closely to school data/pupils' needs. Additional release time for teachers to meet with senior leaders. External review of CPD programme and school procedures.
Targeted support	Ensuring enough time, above and beyond quality first teaching, is given to support pupils' with gaps in learning	Additional afternoon support put in place to ensure targeted interventions do not take pupils away from class teaching. Structured interventions matched to evidence based research.
Wider strategies	Building closer links with the most vulnerable disadvantaged families to increase engagement.	Changes to communication procedures with disadvantaged families. Increased provision for those families who are struggling.
